Commitment

TEIKEI is a civil movement and network dedicated to promoting a regenerative, solidarity-based, and transparent agricultural economy across Europe. TEIKEI supports not only small-scale farms but also connects producers, consumers, and communities to collectively create a sustainable and fair supply chain. Our goal is to develop a resilient and eco-friendly food system through direct collaboration between all participants, strengthening both nature and communities.

Vision 2030

i. Agriculture, the Pulse of Civilisational Transformation

TEIKEI recognises that agriculture is not merely an isolated sector, but the most fundamental pillar of human civilisation. At the heart of TEIKEI's transformative vision are the Three Sacred Circles: economy, relationships, and art. These represent the fundamental pillars of a regenerative society. Economy sustains our physical needs, relationships foster community resilience, and art fuels cultural and creative growth. Through the integration of these circles, we aim to rebuild our connection with the land, nurture strong communities, and cultivate an economy that sustains both material and spiritual well-being. By integrating these sacred circles into every aspect of our work, we ensure that future generations inherit a system that nurtures both the land and the soul, fostering enduring connections between nature, people, and culture. It is from the soil - where life begins and is sustained - that we aim to foster a deeper transformation of societal systems. We understand that the preservation and nurturing of life is the most essential

responsibility on Earth. This life-centred approach is not confined to farming but extends into every sphere of human existence, where the balance between nature, people, and community must be restored. TEIKEI is committed to creating systemic change that ensures the survival and flourishing of all life forms. Our vision is rooted in the belief that humanity must realign its values and systems with the principles of regeneration and sustainability, knowing that the true wealth of civilisation lies in its capacity to protect and sustain life.

iii. Regenerative Systems and Agriculture

By 2030, all TEIKEI farmers will have adopted the principles of regenerative agriculture, achieving Level 3 of our regenerative roadmap. This commitment extends beyond agriculture to every step of the supply chain, ensuring regeneration happens at all levels. From soil health and biodiversity on the farms to the use of renewable energy and waste reduction in packaging and logistics, regeneration will be a guiding principle. This holistic approach strengthens the entire TEIKEI ecosystem and promotes sustainability through shared responsibility, ensuring long-term resilience for future generations. TEIKEI is committed to fostering a culture of continuous learning and knowledge sharing across its network. All members - including farmers, consumers, and partners - contribute to a shared knowledge pool that is constantly evolving. Regular training sessions, exchange programs between communities, and the development of knowledge resources ensure that each group is equipped to address the challenges of sustainable agriculture. By sharing knowledge across the network, we ensure that each community is equipped not only to meet today's challenges but also to innovate and adapt to future needs. This ongoing exchange of ideas, techniques, and insights is key to building a resilient and regenerative food system.

iv. Circular, Shared-Risk Economy for the Common Good

We are committed to creating circular, shared-risk economic structures that emphasise collaboration and collective well-being over individual profit. Our

networks are owned and governed by the community, transitioning away from single-owned models to participatory and cooperative systems. TEIKEI's circular economy is rooted in the understanding that economy, relationships, and art are sacred and interconnected. This approach fosters a regenerative system that supports not only financial well-being but also emotional and social health, while promoting creativity and cultural expression. Our circular, shared-risk model embraces these three sacred circles to create an economy that nourishes communities in multiple dimensions, ensuring a balance between material and cultural wealth. The organisation's structure cannot be owned by any one individual, nor sold for personal gain. Instead, value is created and distributed across all partners and participants. The risk and rewards are shared within the network, ensuring that the organisation remains in the hands of those who actively contribute to and run it, in alignment with our principle of collective responsibility and mutual benefit.

v. Art and Culture as a Bridge for Communities

At TEIKEI, we recognise that transforming the food system is not just about logistics or economics - it's also about the emotional, cultural, and spiritual connections that bind people together. Art and culture have the power to strengthen these bonds, fostering deeper engagement, a shared identity, and a sense of purpose within our communities.

At TEIKEI, spirituality is reflected in the way we care for the land, respect natural cycles and the natural order, and build meaningful relationships with one another. This spiritual connection informs our farming practices, ensuring that we honour both the environment and the communities that depend on it. Through mindful practices, we aim to create not just physical, but spiritual nourishment for all. We understand that art, culture, and spirituality can bring people together in powerful ways. Through cultural projects, creative activities, and a deeper spiritual connection to the land, we

don't just make things more beautiful; we help build a sense of belonging and shared identity.

At TEIKEI, we recognise the importance of integrating three sacred circles of relationships: economy, relationships, and art. These circles represent the key aspects of our interconnected world. The economy supports our livelihoods, relationships provide emotional and social stability, and art nurtures our creativity and cultural identity. By embracing the overlap of these sacred circles, we build stronger, more resilient communities.

At TEIKEI, the Three Sacred Circles - economy, relationships, and art - are not abstract concepts but deeply embedded in our everyday actions. The economy sustains not just livelihoods by supporting local farmers and producers, but also nurtures strong community relationships through cooperative financial models that prioritise fairness and shared risk. Relationships are cultivated through direct, transparent exchanges between farmers and consumers, creating a sense of belonging and shared purpose. Art, meanwhile, plays a vital role in bringing people together, fostering creativity, and strengthening cultural connections through community projects, festivals, and collaborative activities. By integrating these circles into our work, we create a holistic system where economic, social, and cultural well-being are equally valued.

This synergy reflects our commitment to a future where art, culture, and economic well-being are deeply intertwined, allowing communities to flourish in harmony with nature. Our cultural and spiritual commitments ensure that the wisdom of past generations and the creativity of present communities will leave a lasting impact for future generations. By integrating these elements, we aim to create a sustainable food system that nourishes not just the body, but the soul - preserving our values and ensuring a thriving future for all.

V. Energy Independence and Regenerative Resource Use

To achieve true sustainability, TEIKEI recognises that energy independence is essential. By 2030, all actors within the food supply chain will operate without the need for fossil fuels, relying instead on locally produced, renewable energy sources. However, energy independence is only part of the transformation. It must be paired with a holistic, regenerative approach to resource use. Waste is not simply reduced—it is eliminated, as TEIKEI moves toward circular, zero-waste systems that regenerate themselves. Packaging, transportation, and distribution are redesigned to work in harmony with the environment, creating a system where all resources are reused, renewed, and integrated back into the ecological cycle. In this way, TEIKEI builds an economy that flows without disruption, mirroring the natural world's ability to sustain itself.

We are dedicated to building strong, personal relationships with all producers and consumers in our network. By fostering direct communication,

We fully support **Fair Trade** practices, ensuring that all parties involved receive fair compensation. We go beyond standard Fair Trade by promoting full transparency in pricing and value creation throughout the network.

We are deeply committed to building a regenerative, transparent, and community-based agricultural economy, supporting the vision for 2030 by following these core values. TEIKEI not only implements these principles within its own network but also actively supports and participates in the commitments of our members, partners, and other organisations to ensure their successful implementation. Each point below reflects these principles and is tied to one or more of TEIKEI's Ten Principles.

i. Fair-Share-Rate and Efficient Systems

Our members, enterprise network, and primary suppliers are committed to developing new organisational pathways and processes that ensure farmers receive between 50% and 90% of the final retail price. This will be achieved

by implementing direct trade models, optimising logistics through local distribution networks, and fostering cooperative structures. These measures maintain high product quality, lower consumer prices, and reduce reliance on conventional wholesale models.

ii. Shared-Risk Economy and Harvest Commitment

Our members, enterprise network, and primary suppliers are committed to a shared-risk economy that ensures risks and rewards are collectively managed throughout the network. As part of this principle, the harvest must be announced by the producers, and once announced, it must be accepted by the members and partners in the network. This guarantees financial security for farmers while fostering a deep sense of mutual responsibility.

iii. Mutual Assistance

Our members and primary suppliers actively practice mutual assistance, ensuring that both producers and consumers are protected in times of need. This principle strengthens resilience within the network by fostering a strong sense of community support, especially during difficult times for either farmers or consumers.

iv. Intended Production

Our members and producers agree on the intended production levels at the beginning of each cycle. This coordination between producers and the network ensures that only what is needed is grown, minimising waste and aligning the harvest with actual consumption needs.

v. Support for Small-Scale and Community-Based Farming

Our members, enterprise network, and primary suppliers support small-scale farming in all its forms—whether it's tiny farms, individual

smallholders, or community-supported agricultural projects—by sourcing products from sustainable networks and prioritising unprocessed foods over heavily processed alternatives. This strengthens the regional economy and solidarity, promoting sustainable farming practices in line with TEIKEI's values.

i. Regenerative Agricultural Methods and Soil Health

By 2030, farmers will implement regenerative methods that actively improve soil health and biodiversity. Healthy soils are the foundation of sustainable agriculture, prioritised to maintain ecological balance. This long-term commitment fosters resilient ecosystems and sustainable agricultural practices for future generations. The progress will be tracked through

regular measurements of soil fertility and biodiversity, ensuring transparency and continuous improvement.

ii. Generational Land Stewardship and Local Food Accessibility

Farmers adopt a model of land stewardship that ensures equitable access to land and food for future generations, prioritising local food distribution before exporting to external markets. This commitment strengthens regional food security and sustainability. Any surplus is only exported after the local community's needs are fully met, reinforcing local food sovereignty.

iii. Organic and Regenerative Farming without External Certification

Farmers follow organic and regenerative principles without relying on third-party certifications like EU Organic or DEMETER. TEIKEI's Participatory Guarantee System (PGS) ensures transparency and community-based quality assurance. The focus is on avoiding any practices that harm soil life or beneficial insect populations, preserving the natural balance by using only locally sourced natural fertilisers.

iv. Producing High-Quality, Nutrient-Rich Food

Farmers strive to produce the highest quality food, rich in secondary plant compounds, which contribute to human health and environmental well-being. The natural shapes and forms of the products are respected, reflecting the uniqueness of nature's processes and avoiding unnecessary standardisation. This commitment ensures the integrity of natural production and provides wholesome, nutrient-dense products.

v. Business Transparency and Cooperative Income Models

Farmers provide transparent access to their business plans and pricing structures while creating sustainable incomes through cooperative

This includes a gradual shift towards renewable energy and a complete phase-out of single-use plastics in agricultural practices.

By fostering this collaborative learning culture, we strengthen our resilience and ability to respond to ecological and social challenges.

establishing long-term partnerships, providers can grow with TEIKEI while maintaining their own development paths.
